Introduction

In 2013 the International Union for the Scientific Study of Population continued its work to promote population science, foster international networks of population scientists worldwide and support interaction between research and policy. The major activities of the year included the XXVII International Population Conference and IUSSP General Assembly, the election of new officers and Council members for 2014-2017, and the completion of two distance learning projects funded by UNFPA. In addition the IUSSP maintained an active programme of seminars, workshops and publications, and continued with the work of updating the new website. This annual report highlights recent outcomes of these activities.

XXVII International Population Conference

The IUSSP organized its XXVII International Population Conference in Busan, Korea from from 26 to 31 August 2013. Over 2,100 population scientists, students and policy makers from 106 countries attended the conference to present and share their research and exchange on population issues in formal and informal events planned during the Conference. All regions were represented at the Conference in large part thanks to financial support made available for members from low and middle income countries (see Table 1, based on region of residence for 2,101 participants listed in the database). Almost half of registered participants were women and in general participants represented young and mid-career researchers with one-third of participants less than 35 and 59% less than 45 years old. Thirty-one percent of participants were students.

The Conference programme, which was organized around 268 regular sessions and 4 poster sessions covering 22 major themes, included 984 oral paper presentations and 485 posters. The regular programme also included 3 sessions on training and 8 invited sessions, including 4 sessions organized by regional population associations from Latin America, Africa, Asia and Europe. The Korean National Organizing Committee (NOC) organized 8 special sessions focusing on issues of particular relevance to the Asia Pacific region.

In addition to the regular and poster sessions, there were also 4 plenary sessions, 25 side meetings and 32 exhibit booths set up by a diverse array of institutions working in the population field. A Welcome Reception was hosted by the Mayor of Busan Metropolitan City and a special banquet dinner was offered by the Korean NOC.

Thanks to funding from UNFPA, the William and Flora Hewlett Foundation, the Wellcome Trust, and the Korean government, the IUSSP and the Korean NOC were able to provide support to 301 participants from 55 countries. Additional participants were supported directly by the Australian Agency for International Development (AusAID) and UNFPA Country Offices. The IUSSP received a record 738 requests from participants seeking support to attend the Conference, but could only offer funding to 41% of those requesting assistance. Funding decisions took into consideration the applicant's role in the Conference programme and the income status of applicant's country of residence. Funds were allocated in priority to applicants residing in low-income countries who were first author of a paper on the regular programme. The majority of participants, over 85%, attended without any funding from Conference organizers; the IUSSP is most grateful to those participants and their institutions.

After the conference, the IUSSP asked conference participants to evaluate the quality of the Scientific Programme, logistics, accommodation facilities, translation, etc. Results from this survey indicate a very high appreciation of the conference and its scientific quality. 27th General Assembly

The IUSSP held its 27th General Assembly during the International Population Conference in Busan, Korea on 29 August 2013. Approximately 300 members attended the meeting. Emily Grundy, the Secretary General and Treasurer, reported on the Union's activities and finances for the 2009-2013 period. The General Assembly also elected the Committee on Nominations whose members will propose a slate of candidates for the 2017 Council Elections. The 2014-2017 Committee on Nominations includes Francesco Billari (Italy), Bruno Schoumaker (Belgium), Alejandra Silva (Chile), Akim Mturi (Tanzania), John Casterline (United States), and K.G. Santhya (India) and will be chaired by the outgoing President Peter McDonald.

IUSSP members from South Africa and India declared their respective country's interest to host the 2017 International Population Conference. In December, the IUSSP Secretariat received bids from both countries to host the Conference in Cape Town, South Africa or Mumbai, India.

Awards

Two awards to IUSSP members were presented during the International Population Conference: the IUSSP Laureate Award and the IUSSP-Mattei Dogan Foundation Award for Comparative Research in Demography; the latter is bestowed every 4 years during the IUSSP International Population Conference.

IUSSP Laureate Award

Each year the IUSSP honours one of its outstanding members with the IUSSP Laureate Award. The 2013 IUSSP Laureate Award was presented to John Bongaarts at the International Population Conference in Busan during the IUSSP General Assembly meeting

held on 29 August 2013. John Bongaarts, vice president and Distinguished Scholar at the Population Council, is best known for two major contributions to the analysis of fertility: the proximate determinants of fertility and the distinction between quantum and tempo of fertility. John Bongaarts's proximate determinants of fertility broke fertility into its constituent biomedical parts: exposure to intercourse, fecundability, contraception, abortion, and postpartum infecundity associated with birth, the birth process and with breastfeeding. These elements were combined in an attractive, straightforward equation that provided many extremely important insights into the total fertility rate. John Bongaarts, with Griffith Feeney, also developed and applied a more precise version of Norman Ryder's distinction between quantum and tempo, which demonstrated that fertility in Europe during the 1990s and the early years of the present century has been substantially depressed by the delay of childbearing to older ages in later generations. Mattei Dogan Award

In 2005, the Mattei Dogan Foundation established an IUSSP-Mattei Dogan Foundation Award for Comparative Research in Demography to be bestowed every 4 years to an IUSSP member during the IUSSP International Population Conference. The award honours a mid-career scientist of international renown for the contribution of his or her work to the development of studies of population that draw on perspectives of different disciplines and for the importance that this work has accorded to international comparisons. In 2013, the award was bestowed to Gunnar Andersson, Professor of Demography at Stockholm University (Sweden), during the Closing Ceremony of the XXVII International Population Conference in Busan, Korea. Gunnar Andersson has made ground-breaking contributions concerning the impacts of public policy on fertility and family dynamics, including important contributions on methodological aspects of comparative policy studies in demography. His work combines the best of comparative political-science and sociological insight with the methodological rigor of demographic research. Council Elections

The 2013 IUSSP Council Election was conducted between 30 July and 1 October using online voting software provided by Votenet Solutions for the ballot and tabulation of votes. A total of 2,184 members were eligible to vote, of which 1,237 (56.6%) cast their vote – the largest participation rate for any recent IUSSP election, surpassing the number of voters in 2009. Voter participation was important for all regions, and especially high for Latin America and the Caribbean and Europe. The results of the online ballot and the procedures carried out for the 2013 IUSSP Election were reviewed and approved by the members of the Election Committee: Véronique Hertrich, Catherine Rollet and Laurent Toulemon.

The newly elected Council for 2014-2017 will be presided by Anastasia Gage (Sierra Leone/United States), who was elected in 2009 as Vice President 2010-2013 and automatically becomes President for 2014-2017. Newly elected members include: Vice President Tom LeGrand (Canada), Secretary General and Treasurer France Meslé (France), and Council members Sajeda Amin (Bangladesh), Ann Biddlecom (United States), Parfait Eloudou-Enyegue (Cameroon), Emily Grundy (United Kingdom), Fatima Juarez (Mexico), Oystein Kravdal (Norway), David Lam (United States), Tom Moultrie (South Africa), Edith Pantelides (Argentina) and Sureeporn Punpuing (Thailand). Peter McDonald was elected Honorary President of the Union.

Membership and Governance

As an association based on individual membership, the IUSSP's principal strength is its members. The majority of IUSSP activities are carried out through members' voluntary contributions of their expertise and time. At the end of 2013, IUSSP included 2,076 full members and 504 student associates from 126 countries and 135 nationalities around the world. In 2013, 317 new members and 277 new student associates joined the Union. Women comprise 43% of full members and more than half of student associates.

IUSSP Seminars, cyberseminars and training workshops

In 2013, besides the XXVII International Population Conference, IUSSP Scientific Panels and collaborating institutions organised eight scientific meetings including four seminars, two training workshops and two cyberseminars. Approximately 240 individuals directly participated in IUSSP scientific activities delivering 82 papers and communications. Another 670 were registered for PERN cyberseminars and received cyberseminar postings by email.

In order to facilitate the participation of students and scholars from developing countries the IUSSP provides some travel support when funding is available. In 2013, the IUSSP provided direct support for travel to 56 IUSSP members from developing countries to attend an IUSSP seminar or training workshop. Panel members and the IUSSP Secretariat raised and managed funds from seven donors to provide travel support and collaborated with nine institutions in the organisation of the following seminars, workshops and meetings:

Training activities

In 2013, two IUSSP projects carried out with funding provided by UNFPA to create Open Distance Learning (ODL) materials came to completion and the Panel on Strengthening Demographic Training in Francophone Africa, supported by the Hewlett Foundation, organized several training activities in Africa and at the IUSSP 27th International Population Conference in Busan, South Korea.

Tools for Demographic Estimation

Final revisions to Tools for Demographic Estimation were made in 2013 and a hardcopy version was printed and distributed at the 2013 International Population Conference. Tools for Demographic estimation can be accessed on the IUSSP website at <http://demographicestimation.iussp.org/>. At the end of 2013, the website had 2,705 visitors from 147 countries accounting for 4,753 visits; 354 downloads of the full PDF document were registered. Updated online materials will remain available on the IUSSP website as an open source learning and teaching tool that can be revised and modified in the future. Translation of the materials into French was begun at the end of 2013.

Population Analysis for Programs and Policies

Modules 1-3 of Population Analysis for Programs and Policy was made available on the IUSSP website. London School of Hygiene and Tropical Medicine completed Module 4 "Demographic Analysis: Applications and Extensions" with a focus on "Demography and Health" and "Fertility and Family Planning."

Strengthening Demographic Training in Francophone Africa

The William and Flora Hewlett Foundation renewed a 2-year grant to support a second phase of the project to be carried out by the IUSSP Panel on Strengthening Demographic Training in Francophone Africa. In 2013, the panel organized two training workshops for population researchers and students in the region: one workshop in Dakar, Senegal on Q-GIS, an open-source GIS software for mapping, and a second workshop in Ouagadougou, Burkina Faso on the demographic dividend. The Panel also held a workshop for journalists on understanding population statistics and organized a training session at the International Population Conference in Busan, South Korea to assist participants in the network with their scientific presentations at the Conference. The IUSSP also supported CARE-IFA (Cellule d'Appui à la Recherche et à l'Enseignement des Institutions Francophones d'Afrique), at IFORD in Yaoundé, Cameroon and a database manager at ISSP to provide support for data analysis and database management in the region.

Publications

The IUSSP disseminates the scientific results of its activities through its website, in scholarly peer-reviewed journals and edited volumes. In 2013, one book based on a series of online distance learning modules was published; two special issues of peer-reviewed journals were devoted to papers from IUSSP seminars; other papers from IUSSP seminars were published individually but these are more difficult to trace. Seminar papers are made available to IUSSP members and all seminar reports are available to the general public on the IUSSP website (www.iussp.org).

IUSSP Participation in meetings organized by the United Nations

The IUSSP has Special Consultative Status as an NGO with the United Nations Economic and Social Commission (ECOSOC). This status gives IUSSP the privilege of participating in United Nations-sponsored meetings. In return organizations are expected to contribute to and support the development aims of the Economic and Social Council and the United Nations. In 2013 the IUSSP delivered recommendations on how to improve data on international migration at the Informal Hearings for High-level Dialogue on International Migration and Development held in New York, 15 July 2013.

IUSSP Website

The IUSSP website has increasingly become the place where IUSSP updates members and the public on its activities as well as upcoming events, calls for papers, publications, grants, and employment opportunities in the population field. We will soon be including an online electronic newsletter that will also be sent to members via email.

In 2010 the IUSSP began a project to refresh its website, install membership management software (civiCRM), and create conference management software to handle the scientific programme and registration for the 2013 International Population Conference. The website project begun in 2010 is thus almost complete. There will be some changes and improvements implemented in 2014 and most importantly more features and information made available to members.

Management and Finances

The year of the IUSSP International Population Conference alters IUSSP finances considerably by increasing our income as well as overall expenditures. In 2013, the IUSSP also completed the conversion from an annual membership dues payment system to a date-to-date dues payment system. This resulted in the allocation to the following years' accounts of 52,662 € in membership dues collected in 2013.

In 2013, IUSSP income totalled 1,585,737 €. Income sources include grants from private foundations and governments to support scientific activities and operational costs, membership dues, conference fees for the XXVII International Population Conference and income from interest earned on investments and exchange rate gains. Conference fees from the 2013 International Population Conference are an important source of income, part of which will be set aside in reserves to cover IUSSP operations and activities in the coming years and to ensure that the next International Population Conference can take place. In addition to the direct support received from donors and institutions for operations and scientific activities, the IUSSP leverages additional funds through Panel members and their institutions, which are not included in our accounts.

The IUSSP operating budget for 2013 was 1,416,101 €. Expenses include: 722,679 € to directly support IUSSP scientific and training activities, 38,551 € for publications and the website, and 83,621 € of unspent grant funds mainly from The William and Flora Hewlett Foundation that were set aside as tied funds for future activities of the Panel on Strengthening Demographic Training in Francophone Africa. IUSSP expenditures on the organization of the International Population Conference totaled 491,466 € of which 291,475 € was spent on travel support to Conference participants from developing countries, 149,173 € on simultaneous translation, and 50,818 € on related costs.

The IUSSP spent 339,599 € on salary costs and related taxes and social security costs including 41,000 € to cover the salary of a temporary Conference Assistant for the XXVII

International Population Conference. Accounting and auditing services, office furnishing and supplies, depreciation on assets and other office expenditures amounted to 55,132 €. IUSSP governance costs, essentially expenditures associated with IUSSP Council and Bureau meetings, the IUSSP Elections, and the General Assembly, came to a total 54,795 €. The IUSSP also incurred costs of 103,493 € in exchange rate and exceptional losses. Finally as IUSSP is required to pay the corporation income tax on investments (10% of investment earnings), a debt of 3,281 € for corporation income tax has been recorded related to IUSSP 2010 capital investments and a 2011 investment in a bond subscription.

The IUSSP income exceeded the IUSSP operations budget by 169,636 €, all of which was received as registration fees for the XXVII International Population Conference.

The benefits from the International Population Conference have been placed in the reserves as follows: 40,000 € added to a reserve to assure IUSSP outreach at meetings of the United Nations and important regional and national population conferences for the 2014-2017 period, 25,000 € in a project reserve to support fundraising activities, 10,000 € added to the reserve to fund IUSSP's efforts to obtain 501(c)(3) status under the United States tax code, 10,000 € added to the reserve for IUSSP scientific activities, 44,636 € added to the reserve for the 2017 International Population Conference, to which will be added unspent reserves allocated for the 2013 Conference, 20,000 € added to the General Reserve, and 20,000 € added to the reserve for contingencies related to unexpected operational costs.

As of 1 January 2014, IUSSP reserves stand at 1,763,433 €, of which 583,463 € are held in general reserves, 263,883 € are in a reserve for contingencies, and 916,087 € have been set aside in special project reserves. The special project reserves include funds set aside for the 2017 International Population Conference (511,326 €), the 2017 IUSSP General Assembly (30,000 €), IUSSP Policy and Research Papers (43,134 €), a Teaching Materials Project (10,000 €), Scientific Activities (103,543 €), Technological Innovations (118,084 €), US 501(c)(3) Status (35,000 €), Fundraising Activities (25,000 €) and Outreach Activities (40,000 €).

The assets of the IUSSP are held in several secure investments. In 2011, the IUSSP subscribed to a bond issued by BFCM for a total of 250,000 €. This bond has an annual coupon of 4.10% and a maturity of 5 years. In addition, the capital investment subscribed at the end of 2010 (500,000 €) resulted in interest earnings in 2013 of 14,442 €. The remaining assets have been placed in a tax exempt Euro SICAV accounts with Banque Transatlantique. The IUSSP also has U.S. dollar accounts with Banque Transatlantique and with Tompkins County Trust Bank in New York, USA.

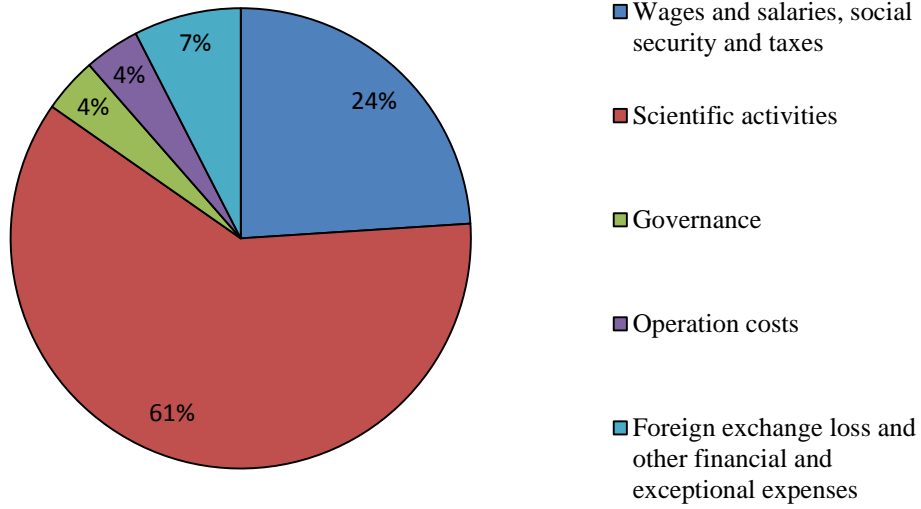
The Secretariat currently has four permanent staff members who coordinate IUSSP scientific activities and publications, communicate with IUSSP members, donors and the public, maintain a website, and coordinate fundraising and reporting to IUSSP donors. In 2013 IUSSP hired a Conference Assistant for 10 months to assist with registrations and financial requests for travel support.

The IUSSP 2013 audited accounts were prepared by the accounting firm ARICE and approved by auditors Mazars & Guérard. For further details on IUSSP revenue and expenses in 2013 see the Statement of Activities and Change in Net Assets for the Year Ended 31 December 2013 below. Comparable data for 2010-2013 are shown in that statement. The Statement of Financial Position as of 31 December 2013 shows IUSSP total assets and liabilities for the period 2010-2013. In compliance with article D.441-4 of the French *Code du Commerce*, a table showing the balance of debts to suppliers for 2013 can be found on page 16.

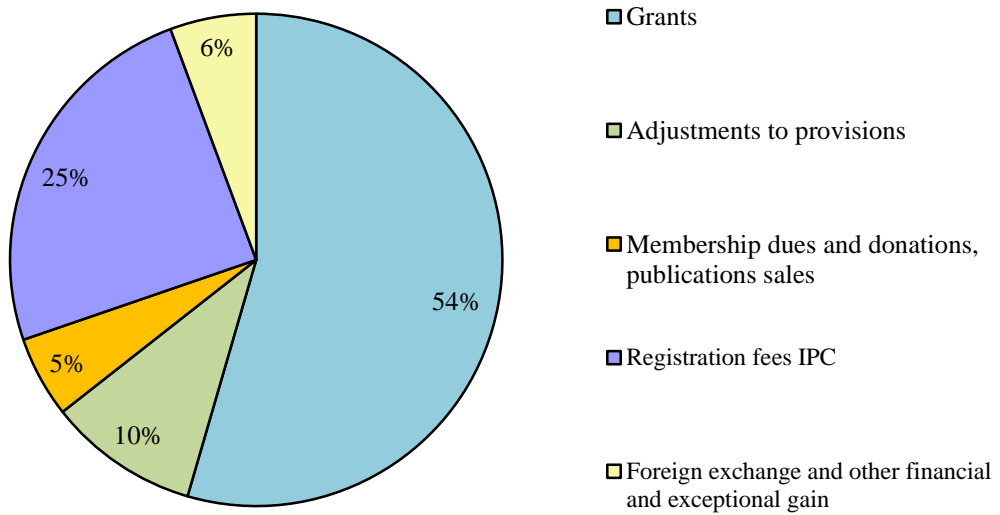

Annex 7: Summaries of 2013 Scientific Meetings and Training Meetings

Seminar on “Past and Present. Revisiting the Demographic Transitions in the South through Individual Longitudinal Data,” Mumbai, India, 17-18 January 2013

This seminar was organized by the IUSSP Scientific Panel on Historical Demography in collaboration with the International Institute for Populations Studies (IIPS) and with financial support from the University of Geneva and UNFPA. Fifty-one participants attended the meeting including the twelve authors presenting their papers – from India, USA, Canada, UK, France, Italy, Spain, Switzerland and Cameroon –, Indian and international scholars invited to chair the different sessions and participate in the debates, as well as faculty members and students from IIPS. The twelve papers presented analysed individual longitudinal data, using different methodological approaches, to study the fertility and mortality transitions in Africa, India or Europe. Seminar on “International Migration in the Middle East and North Africa after the Arab Uprising: A Long Term Perspective,” Cairo, Egypt, 22-23 April 2013

This seminar was organized by the IUSSP Scientific Panel on International Migration in collaboration with the Center for Migration and Refugee Studies (CMRS) at the American University in Cairo (AUC) and with financial support from the Economic and Social Research Council ESRC/UKAID and the League of Arab States. Forty-seven persons participated in the seminar, including 19 authors from Egypt, Sudan, Tunisia, Morocco, Lebanon, UK, France, and Italy, and a number of representatives of international organizations and the Egyptian government. The seminar papers aimed at investigating the long-term impact of political and economic change in the region and their impact on the migration system of the region after the 2011 Arab uprising. Seminar on “Is Access Enough? Understanding and Addressing Unmet Need in Family Planning,” Nanyuki, Kenya, 14-17 May 2013

This seminar was organized by the IUSSP Scientific Panel on Reproductive Health in collaboration with the Strengthening Evidence for Programming on Unintended Pregnancy (STEP UP) Consortium and the African Institute for Development Policy (AFIDEP) and with financial support from the US Agency for International Development (USAID), the Wellcome Trust, and the World Health Organization’s Department of Reproductive Health and Research (WHO/RHR). This seminar brought together 44 scientists, policy makers, and programme managers to present and discuss a range of issues relating to the definition, determinants and consequences of unmet need for family planning and programme interventions designed specifically to reduce unmet need in groups at high risk. Twenty-five papers were presented, including one paper that systematically reviewed the evidence on unmet need and its causes and one paper reviewing the evidence on unintended pregnancy. Overall, the seminar papers, presentations and discussions asserted that physical access is no longer the primary barrier to addressing unmet need for family planning and that a range of other individual, community and delivery system characteristics need to be considered. Cyberseminar on “IPCC's New Scenario Process: Shared Socioeconomic Pathways,” 7-14 October 2013

This cyberseminar was organised by the Population-Environment Research Network (PERN) and focused on the Intergovernmental Panel on Climate Change (IPCC) Shared

Socioeconomic Pathways (SSPs), with the purpose of stimulating the discussion on this new methodology. Leiwen Jiang of NCAR's Integrated Assessment team in the Climate Change Research Group co-moderated the seminar with Susana Adamo of PERN. Two background documents and four statements written by six invited experts served as a basis for discussions. Fourteen researchers posted a total of 27 contributions, which were accessible to the 670 subscribers to the PERN-Seminars list. Cyberseminar on “UNFCCC's New Work Program: Loss & Damage from Climate Change,” 28 October -1 November 2013

This cyberseminar was organised by the Population-Environment Research Network (PERN) and the United Nations University-Institute for Environment and Human Security (UNU-EHS) and was moderated by Dr. David Wrathall of UNU-EHS. In November 2013, at the United Nations Framework Convention on Climate Change (UNFCCC) Conference of Parties 19 in Warsaw, institutional arrangements for an international mechanism to address “loss and damage” will be part of negotiations. But what is “loss and damage”? How does it relate to climate change mitigation and adaptation? How will it affect the populations that are most vulnerable to climate change impacts? Before the policy debates begin, this cyberseminar aimed to clarify the different meanings of “loss and damage” and their possible implications for both research and policy. Five statements written by invited experts served as a basis for discussions. Twenty-nine researchers posted a total of 77 contributions, which were accessible to the 670 subscribers to the PERN-Seminars list. Seminar on A Demographic History of Colonial Populations: Pioneers, Settlers and Mixed Populations (16th-20th Centuries), Lyon, France, 25-26 November 2013

This seminar was organized by the Centre Jacques Cartier, in collaboration with the IUSSP Scientific Panel on Historical Demography. Forty participants attended the meeting including 19 authors of papers and 20 students. The objective of this workshop was to take stock of present knowledge on the formation of new colonial populations and the role played by the mix of people from various ancestries in those processes. Training workshop on the Demographic Dividend in Africa, Ouagadougou, Burkina Faso, 25-30 November 2013

This workshop was organized by the IUSSP Scientific Panel on Strengthening the demographic training in Francophone Africa, in collaboration with the Institut Supérieur des Sciences de la Population (ISSP), University of Ouagadougou and with financial support from the William and Flora Hewlett Foundation. The workshop brought together 29 participants from eleven countries in Africa: Algeria, Benin, Burkina Faso, Cameroon, Chad Congo, Congo DR, Côte d'Ivoire, Mali, Senegal and Tunisia. In a context marked by a major interest in Africa for the concept of demographic dividend, i.e. socio-economic development opportunities related to a decrease in the dependency ratio consecutive to a decline in fertility, this workshop aimed to (1) review the methodological and conceptual advances on the topic; (2) inform and train researchers in the Francophone network on several methods for analysing the dividend; and (3) furthering a collective analysis of the African demographic dividend in the specific field of human capital. Training workshop on Using "Quantum GIS" (QGIS) Software to Present Census Data, Dakar, Senegal, 17-21 June 2013

This workshop was organized by the IUSSP Scientific Panel on Strengthening the demographic training in Francophone Africa and the Observatoire démographique et statistique de l'espace francophone (ODSEF), Université Laval (Canada) in collaboration with the Agence universitaire de la Francophonie (AUF) and with financial support from the William and Flora Hewlett Foundation. The workshop brought together 25 participants (8 women and 17 men) from 17 Francophone African countries: Algeria, Benin, Burkina Faso, Cameroon, Cape Verde, Congo, Côte d'Ivoire, Djibouti, Gabon, Guinea, Mali, Mauritania, Niger, Rwanda, Senegal, Togo and Tunisia. Francophone African countries tend not only to underuse results from population censuses and other surveys but they also rarely use geographic mapping to present statistical results in scientific research reports. In this context, the Panel decided to propose this workshop to train demographers in these countries to use free software called "Quantum GIS" so that they produce maps to present their research within their institutions and to other publics. The workshop evaluation attests to its success among participants.
